PURPOSE/SCOPE:

The purpose of this section is to provide the forms required by the Disclosure Ordinance 90-28.

POLICY/PROCEDURE:

The Disclosure Ordinance 90-28 requires a disclosure form which will be used by the Department of Community Development and which will reflect the various categories of disclosure required pursuant to the ordinance. A sample of the specific form to be used is attached. This form is to be used for owner-initiated rezonings only, not for County-initiated rezonings.
